TERMS & CONDITIONS FOR SPONSORS

Sponsors:

Sponsors shall respect the Thai law and not undertake any illegal or unlawful activities.

Sponsors may attend appropriate Club functions and display their products and/or services, and speak to the members before and after the meeting, as well as during the coffee break. There should be no communication with members during the meeting and the members have to be aware of this.

Sponsors should check the website for current functions (meeting dates).

Sponsors shall, per occasion, inform the Club at least one (1) week in advance of their intention to attend a Club function.

Sponsors are allowed to be in the sponsorship area with their own name tags, or the Club's IDs identifying them as a Sponsor.

Sponsors have no rights to vote in the matters of the Club unless they are Club members.

The Sponsor shall, for posting at the Club's website, provide;

- 1) A Company Logo (about 160 x160 pixels and no more than 25 KB (25000 bytes) and
- 2) Links to the Sponsor's website and/or social media, provided the websites are active, stable and monitored by the sponsors [no broken links].
- 3) The Company's registration number and location.

Together with the issuing of his Logo and/or Links, the Sponsor accepts the Terms & Conditions as posted at the Club's website.

Sponsors have the right to post an announcement (max. 100 words) and to update his Logo and/or links once / year, free of charge.

Additional mutations will, per time, be charged with 20% of Sponsor's annual fee.

General:

- 1) Club functions, meeting dates, and eventual changes, will be posted at the Club's website well in advance.
- 2) Club meetings shall as a standard, except December (no meeting), January (annual meeting) and/or as decided otherwise, take place every last Sunday of the month from 14.00 hrs till 16.00 hrs. Room shall be open at 13.00 hrs and closed 16.30 hrs.
- 3) The meeting room will, where possible, be equipped with tables, chairs, microphones, laptop connections with beamer, projection-screen and whiteboard.
- 4) The Sponsor shall be responsible for any damage caused by his doing.
- 5) The Sponsor shall be aware that he shall not cause any inconvenience to the Club or the Premises used, in performing his activities.

Either party may terminate the Sponsorship on condition that one (1) full month notice is given by any one of the parties. No reimbursement of any costs or donation/contribution/fee shall be made.

The sponsorship becomes effective at the date of the donation/contribution/fee and shall be valid for 12 months.

In case neither of the parties indicates the intention or will to modify or end the sponsorship, the sponsorship shall be extended for an additional year without any notice.
